Re: Issue of Options under Ambertech ESOP

Please find attached an Appendix 3G in respect of an issue of options under the Company's Employee Share Option Plan.

1,600,000 options are being issued under the Company's ASX listing rule 7.1 capacity and shareholder approval is not being sought (although the Company may seek ratification of the issue in the future).

A further 500,000 options have been offered to the Company's Managing Director, but the issue of those options is subject to prior shareholder approval being obtained under ASX listing rule 10.11.

A summary of the terms of the option plan are attached.

Summary of Key Terms of the Ambertech Share Option Plan – Issue December 2020.

The Board proposes to issue 2,100,000 options, at an exercise price of \$0.22, expiring on 18 December 2025.

The strike price of \$0.22 reflects a premium of 20% to the 20 Day Volume Weighted Average Daily market price for the Company's shares at the time they were approved by the Board.

The options will be issued for no consideration (but with an exercise price as described below)

Each option entitles the holder to subscribe for a fully paid ordinary share in the Company at a price of \$0.22 per share at any time during the option exercise period.

The options will be subject to the following vesting schedule;

One quarter of the options will vest on 30 June 2021;

One quarter will vest on 30 September 2021;

One quarter will vest on 30 September 2022; and

The remaining quarter of the options will vest on 30 September 2023.

The vesting of options has performance hurdles attached including profitability and dividends.

The options will expire five years from the date of issue;

Options to be issued to a Director, Mr Peter Amos, will be subject to approval by Shareholders under Listing Rule 10.11. It is anticipated that this approval will be sought at the 2021 Annual General Meeting of Ambertech.

The options are expected to be issued on 18 December 2020.
